## SUMMARY OF DISCUSSION

### **Malawi MoH and team, Q+A (20 mins)**

#### Overview of data and digital issues in Malawi needing greater alignment

MOH\_Malawi-Maganizo Monawe

- Briefing on high level progress for digital health
- At national level, the Digital Health Strategy is now available
- It has seven key objectives and four key high priority areas
- Priority areas are;
  1. Supporting digital health infrastructure, making digital devices available to healthcare workers and ensuring internet connectivity
  2. Improving interoperability
  3. Continuous Professional Development and capacity building
  4. Deployment of digital tools to secondary and tertiary hospitals and integrating electronic health record systems in Hospital Information System blueprints
  
- The blueprint is a component of the National Hospital Information System architecture
- This is an integrated electronic health record system or hospital Information System blueprint
- The blueprint provides the functional requirements for any platform that is developed
- So any digital health platform should comply with the functions outlined and fit into the national digital health interoperability architecture
- Both the roadmap and the blueprint are available
- A number of systems at national level have been integrated and are sharing data
- The Ministry has established a governance structure
- The governance involves executive and collaborative processes
- On the executive side; the Director of Planning and the Policy Development are responsible for digital health
- On the collaborative, the digital health technical working group, which has a number of subgroups and there is also an overarching steering committee, although the committee is not yet functional
- Based on the vision of the Ministry it is important to align partners so that all are implementing the same blueprint
- We would also like a mapping exercise of partner investments and to conduct a high level donor symposium to bring together heads of missions, donors and implementing partners
- Important also to align platforms to the national digital interoperability blueprint
- Specifically the birth and deaths registration platform

WHO-Azza Badr

- Is the birth and death system already in place, or is it just a plan of action?
- Where is the system based, at Ministry of Health or another Civil Registration Authority?
- Is the notification from the Ministry of Health electronic or paper based?

MOH\_Malawi-Maganizo Monawe

- The birth and death registration system is the part of the National Civil Registration and Vital Statistics platform, which is implemented by the National registration Bureau.
- This is under the Minister of Homeland and Internal Security
- They work both with the Ministry of Health and Ministry of Local Government
- The notification from the facilities is both electronic and paper based

WHO-Azza Badr

- **I want to offer support in making birth and death registration system from the facilities electronic through DHIS2 or otherwise**
- **Please contact us, we are ready to help**

WHO\_Malawi - Dr. Solome Nampewo

- In addition there are linkages between Primary Health Care and quality improvement and then the health development and Health Data Collaborative initiatives, plus the Digital Health WG

MOH\_Malawi - Maganizo Monawe

- In terms of relationship with the HDC the key areas of collaboration were highlighted and there is need for cooperation between the implementing partners and the donors
- The HDC needs to make sure that donors and partners are working with the government, here there's a lot of room for improvement

MOH\_Malawi - Jacob Kawonga

- Main issue is that of alignment and interoperability amongst the different tools being implemented by partners

PHCPI-Jeff Markuns

- Interested to more about what kind of support from HDC might be most useful
- **PHCPI is working with the Global Fund, GIZ and Malawi MOH**
- The work has stalled for some time due to consultants leaving but would like to know how we can use the HDC platform to help support and move things forward

- Thank you Jeff
- **In addition to what was outlined in the slides an investment mapping exercise would also be needed**
- This would allow to understand better where the gaps are
- We are able to interact with partners at the local level, but to get more alignment and additional support we need lobbying at global level

Data and Digital Governance WG-Vikas Dwivedi

- Has the Malawi team developed a costed investment plan to tell us how much is funded and how much more funding may be required?

- This is one of the key activities that was highlighted in the slides. It needs to be done alongside the mapping of partners and current investments, so that we know how much we have and where the gaps are
- We can use this to lobby for more funding

HDC Secretariat - KASONDE, Mwenya

- The question on investment mapping; this is part of the HDC 2020-2023 Work Plan as well as a partner mapping exercise
- A short concept note was circulated in the last SRG for consultant support. We've now drafted the terms of reference and for these consultants
- This includes mapping technical and financial investments

HDC Secretariat - KASONDE, Mwenya

- With regards to the countries we increased from four to 10\_initial HDC countries were the Pathfinder countries; Malawi, Cameroon, Kenya and Tanzania
- In 2020 Botswana and Nepal were added
- Additional interest from Zambia and Sri Lanka
- As far as products, UNICEF Community Indicators are almost ready to be released following a multiparty validation process
- New Working Groups have been launched
- The Workplan 2020-2023 has been approved
- We have aligned with UHC2030 and SDG GAP
- We have streamlined the governance
- We held a successful leadership even with strong country leaders at ministerial level
- We've increased our partnerships from 30 to 54 partners and we have a new private sector constituency, as well as strengthening the research academia and technical work networks constituency and the civil society organizations constituency
- With communications, we have improved the website and webinars were held, specifically around COVID 19 modelling and Health Equity Assessment Tools

HDC Secretariat - Craig Burgess

- We acknowledge requests from some of you to either resurrect the epidemic intelligence working group or create a new working group on this topic. We welcome ideas moving forward
- We're suggesting a Southeast Asian and an Africa regional hosted event
- At some stage in October, the world date and forum in burn in October and then again a repeat of last year's leadership event to really keep up the political
- Current focus countries are being aligned with SDG GAP (Nepal, Malawi, Kenya, Uganda)

- More of the milestones are highlighted in the attached slides

UNICEF - Jennifer Requejo (chair)

- **Would suggest an event calendar for the year.** This could also be related to working group outputs.

UKFCDO - Nicola Wardrop

- Is there something planned around the launch of SCORE as this would be one suggestion for a webinar event

WHO-Azza Badr

- Doing some work in Kenya and Uganda and if Malawi is going to be on board, we are happy to extend support to ensure impact at country level, especially in the area of digitizing CRVS systems

- Azza, who are you working currently in country?
