


Why HDC?

- 1. Strengthen common platform of health, CRVS, NSO, partners and CSOs
- 2. Digital transformation: EHR, Telemedicine and RHIS integration
- 3. Setting up governance and technical base for standard and inter-operability
- 4. Capacity building of monitoring mechanism in the health at all levels
- 5. Learning centres at federal and provincial levels for data and digital health

- Set consultation and communication mechanism by HDC to communicate HIS priorities by respective global level authorities to country offices
