### Spotlight on Kenya: Launch of Kenya Health Data Collaborative



The Kenya Ministry of Health hosted a [launch](#) event on May 18 in Nairobi, where representatives from national and county governments, development partners, faith-based organizations, private sector organizations and civil society signed a [joint statement of commitments](#) to support a unified “One M&E Framework.” A detailed roadmap was developed with a focus on data analytics, quality of care, a new national health data observatory, civil registration and vital statistics and informatics. Progress will be reported to the National Health Congress in November.

#### Sierra Leone: Priority M&E Actions Identified

The Ministry of Health and Sanitation on May 12 organized a workshop to identify monitoring and evaluation (M&E) priority actions, with participation from a joint WHO-World Bank Group mission. Four priority actions were identified: 1) implement a health facility survey, including a quality of care component; 2) support the MoH in finalizing the Health Information Strategic Plan; 3) provide guidance and technical assistance to strengthen data quality and analysis at central and district levels; 4) provide guidance and technical support to map functionality of the health facility information systems,

including developing and adopting an interoperability framework for the HIS system.



### Malawi: Common M&E Investment Framework in Progress

A costed M&E plan will form the basis of a common M&E investment framework that will be endorsed by Collaborative partners ahead of the finalized new Health Sector Strategic Plan (HSSP II). This follows a Collaborative mission in November and a WHO technical support mission in April to develop the M&E component of HSSP II, a draft of which is available on the SharePoint.



### DRC: Ministry of Health Approves National Health Plan

The Ministry of Health last month approved the new [National Health Strategic Plan](#) (PNDS 2016-2020). Following a series of workshops in April and May, health partners and the ministry will this month finalize and validate a core indicator list to monitor and evaluate the PNDS and identify M&E priority actions. ### Ghana Pilots New Cause-of-Death Tool

Ghana is piloting a new tool for collecting cause-of-death information developed by WHO that will be part of the health information software program [DHIS2](#), a core tool for Collaborative activities. The module aims to capture cause-of-death information in a more innovative and efficient way, allowing users to select from a simplified list of most common causes. Ghana intends to roll out the module in 20 regional and teaching hospitals by the end of the year. Other countries, including Rwanda, Tanzania, Zambia, Uganda, Bhutan and Nepal, may follow. - **Digital Health and Interoperability working group meeting** June 28-29 in Washington, DC: the group aims to optimize quality and use of information from digital health systems within low- and middle-income countries and increase efficiencies of investments in such systems. - **Civil Society working group meeting / African Regional Health and Accountability Dialogue** in late July (location tbc): this group aims to 1) improve data access and data use to empower policy dialogue and 2) support civil society-led actions to hold both countries and Collaborative partners accountable. - **Workshop on development and implementation of national identifiers in countries** July 6-8 in Geneva, organized by UNAIDS and WHO: countries that have recently developed unique identifier systems for monitoring patients will share their experiences and help develop guidelines for other countries. The meeting is not HIV-specific and will incorporate examples from multiple global regions. Unique identifiers will allow countries to strengthen their programme and disease

- **Stakeholder meeting hosted by UN Foundation** May 12 in Washington, DC: About 30 participants from NGOs, UN and other agencies and advocacy groups attended an informal stakeholder discussion hosted by UN Foundation to raise the profile of the Health Data Collaborative and invite participation in the working groups. - **World Health Assembly** May 23-28 in Geneva: a [resolution](#) on “Health in the 2030 Agenda for Sustainable Development” was passed, requesting the Director-General “to support Member States in strengthening national statistical capacity at all levels, in particular in developing countries, in order to ensure high quality, accessible, timely, reliable, and disaggregated health data including through, where appropriate, the Health Data Collaborative.” This year’s [World Health Statistics](#) report and data visualizations, published by WHO last month, present currently available data on the health-related Sustainable Development Goals.
